Occasionally, the NACSD may request in excess of the TFC spending guidelines, including any or all of the principal and income.
	The Henry County 4-H Endowment Fund	03/21/2019	Annual distributions from this Fund will be made to support 4-H programming in Henry County. It will help to develop citizenship, leadership, responsibility and life skills of youth through experiential learning programs and a positive youth development approach.
	John R. Travis/Larry C. Wesche Outdoor Education Fund	11/13/2006	Napoleon School Board can request a monthly distribution, or funds can be paid every April for operating the NAS outdoor education programs.
Field-of-Interest Fund	HCCF Operating Endowment - Robert Morrison Fund	12/12/2017	This endowment fund will allow the HCCF to request funds from the Toledo Community Foundation when they have a shortfall in fund raising or if a special project is needed for the operation of the organization. Twenty percent (20%) of the most recent quarterly balance can be requested as long as the fund does not fall below \$30,000.
	Robert Morrison Charitable Fund	10/08/2015	HCCF will decide what collaborative project receives the grant from 80% of the annual distribution to preserve, archive, distribute, display, promote, generate interest in historical, ancestral and genealogical activities. Four per cent (4%) of the annual distribution is made to the HCCF Operating Endowment - Robert Morrison Fund. Sixteen per cent (16%) of the annual distribution goes to the HCCF for general operation. Twenty percent (20%) of the most recent quarterly balance can be requested if the fund does not fall below \$30,000.
	Robert and Lou Ann Limbird Henry County Recreation Fund	12/07/2010	Non-voting family member will work with HCCF to select grant recipients. Twenty percent of the most recent quarterly balance can be spent if the fund does not fall below \$25,000.

Scholarship Fund	Morley's Field Scholarship	06/24/2019	Each year, the HCCF will award a one-time, post-secondary educational scholarship for graduating seniors of Napoleon High School pursuing a degree as a full or part-time student at an accredited two or four year educational institution, trade school or technical school. The graduate must have a GPA of 3.0 or higher and have been involved in extracurricular and/or community activities and clubs during their four years as a high school student. A priority for consideration will be football players, cheerleaders, student athletic trainers and managers, and band members.
	Xavier and Aidan Wensink Scholarship Fund	11/01/2018	The HCCF will award two scholarships, annually, to any Patrick Henry High School senior. One scholarship will give preference to applicants with a GPA of 3.0 who lives the Wensink Way. The second scholarship will give preference to applicants with a GPA of 3.5 or higher who have participated in athletics and/or extracurricular/community activities and/or have secured paid employment during high school.
	Frederick H. Germann Scholarship Fund	06/26/2018	The HCCF will annually award the distribution to any high school graduates in Henry County who are at least second year students and meet one of the following: first priority, major in any type of engineering, second priority, descendants of Henry Germann (1866-1941) and Catherine Emma Bahler Germann (1872-1941) of Ottawa County.
	John and Mary Jane Kline Catholic College Scholarship Fund	12/29/2016	The HCCF will award the scholarship to any graduate of a high school in Henry County who is attending a Catholic college or university.
	Henry and Angeline Van Poppel Scholarship Fund	11/23/2016	The HCCF will annually award the distribution to any high school graduate in Henry County pursuing studies in the agricultural field.
	Bernicke Memorial Scholarship Fund	11/01/2011	The Napoleon Area School District will award the annual scholarship to a deserving graduate pursuing a post secondary degree .
	Alex J. Kuser Memorial Scholarship Fund	12/20/2007	The Napoleon High School will award two, one time, scholarships to a graduating senior male active in soccer or tennis.
	Grace N. Cox and Betty Lou Moose Scholarship Fund	10/17/2006	This scholarship is funded by the C/M Memorial Fund. HCCF will decide who receives a scholarship from a high school in Henry and Lucas Counties.
